



## Medicinal Throat-Pharyngeal Cavity Spray

Medicinal product

Please read this information leaflet carefully, as it contains important information that you should take into consideration when using this medicinal product. Please contact your doctor or pharmacist if you have any questions.

### Purpose of use:

Medicinal Throat-Pharyngeal Cavity Spray with its moisturising properties supports the restoration of a physiologically normal and protective function of the mouth and throat mucosa.

It thus contributes in a natural way to the regeneration or restoration of a physiologically normal and protective mucous membrane of the mouth and throat.

### Composition:

*What does Medicinal Throat-Pharyngeal Cavity Spray contain?*

Purified Water, Iceland Moss Spissum Extract (2.8%), Dexpanthenol, Natural Brine Salt Solution (1.5%), Polysorbate 80, Chamomile Fluid Extract, Zinc Sulphate Heptahydrate, Sodium Benzoate, Menthol, Eucalyptus Oil, L-histidine Hydrochloride Monohydrate, Citric Acid, Acesulfame K, Potassium Sorbate, Sorbic Acid.

### Dosage form and content:

*What is Medicinal Throat-Pharyngeal Cavity Spray and what is it used for?*

Dosing spray with 30 ml solution for spraying into the mouth and throat area.

### Area of use:

*When should Medicinal Throat-Pharyngeal Cavity Spray be used?*

To support natural moisturisation of the oral and pharyngeal mucosa in case of:

- Throat ache and hoarseness
- A dry cough and hoarse voice as a result of irritations of the oral and pharyngeal mucosa.

### Contraindications:

*When should Medicinal Throat-Pharyngeal Cavity Spray not be used?*

Medicinal Throat-Pharyngeal Cavity Spray must not be used:

- If you are hypersensitive (allergic) to any of the components of this medicinal product listed under "Composition".
- After operations, in case of injuries or severe inflammations in the throat or pharyngeal cavity.

*Can Medicinal Throat-Pharyngeal Cavity Spray be used during pregnancy and lactation?*

Please ask your doctor or pharmacist for advice if you are pregnant or are nursing, if you think you might be pregnant before using this medicinal product.

### Precautions for application and special guidelines:

No particular precautionary measures are necessary if the product is used in accordance with the intended purpose.

During usage, please hold bottle upright in front of the opened mouth and press the top of the spray fast and firmly downward.

Do not inhale during the application of the product. Please observe that several pushes of the pump button will be necessary on initial use.

For reasons of hygiene, we recommend that you clean the spray attachment after every application by wiping it with a clean cloth. Every spray bottle should be used by one person only to avoid infections.

Do not spray into the eyes.

In order to guarantee the proper quality of the product and the function of the application system over the duration of use, no manipulations may be conducted on the spray bottle.

Any residual quantities are due to technical necessity and have been taken into consideration regarding the filling quantity.

Use by children under 12 years of age should only take place under adult supervision.

**Interactions with other remedies:**

There are no known interactions.

**Fitness to drive and ability to operate machinery:**

No particular precautionary measures are necessary.

**Dosage instructions, type and duration of application:**

*How often and in which quantity should you use Medicinal Throat-Pharyngeal Cavity Spray?*

Children from 6 years of age and adults:

Depending on requirements, use 1 - 2 spray pumps up to 10 times per day (0.14 ml per spray pump) into the oral and pharyngeal cavity.

*How long should Medicinal Throat-Pharyngeal Cavity Spray be used?*

If the complaint does not improve within 4-7 days, please consult a doctor. If required, Medicinal Throat-Pharyngeal Cavity Spray can be used until the complaints subside (maximally 30 days).

**What to do if you use more Medicinal Throat-Pharyngeal Cavity Spray than you should:**

There are no known poisoning and overdose symptoms.

**What are the possible side effects?**

A slight burning sensation in the mouth and throat cannot be excluded.

In individual cases, there may be an intolerance to the ingredients of Medicinal Throat-Pharyngeal Cavity Spray.


The quantification of frequency cannot be predicted on the basis of the available data.

**Reporting of side effects/serious incidents:**

If you notice side-effects or a deterioration in your state of health related to the medicinal product, contact the address provided under "Manufacturers". Serious incidents must be reported to the manufacturer and the competent authority of the Member State in which the user and/or patient is established. This also applies to side effects/serious incidents not stated in this leaflet.

By reporting any side effects, you can make a contribution towards more information being available on the safety of this medicinal product.

**Notes and information on the shelf life of the medicinal product:**

Medicinal Throat-Pharyngeal Cavity Spray may only be used until the  "use by" date marked on the label and the folding box.

Do not use for longer than 6 weeks after opening.

**Storage information:**

Do not store above 25 °C and below 5 °C.

**Keep out of the reach of children!**
